Landscape Committee for Armbrust Acres Viewing Area Phase 2 Recommendations (See Attached)

Phase II recommendations were not approved to the extent the committee was hoping. The all in cost would be about \$13,000, with the HOA bearing 50% of that. After much discussion, a motion was made by Pat M to Plant 2 trees, replacing the 2 damaged by the July storm and to grind the stump of the 3<sup>rd</sup> (Closest to trail); along with obtaining a quote to thin the existing Linden Trees as part of maintaining an asset. *Motion moved by Pat M 2<sup>nd</sup> by Adam J. The motion carried with all in favor and none against, and Jonathan J abstained by a voice vote.* 

Board also agreed that we will wait to see where the Corp of Engineers is at with the fence and maintenance of grasses along the trail. This area is still having an identity crisis. What is the long-term vision and goal of this area. Being that it is "a flood zone" how much do we want to invest? What is the purpose of it? Peaceful sanctuary for neighbors to see the beauty? Place where kids can play pick up games, dogs can run around? Additonal area for neighborhood events? All the above? How do we balance beauty, view and privacy? What do the neighbors want? What can/will the HOA Provide?

## **Landscape Committee for Armbrust Acres Viewing Area**

This is a request for \$6,756 from the Board to fund the Beautification Phase 2 of the AAHA Viewing Area. This represents half of the total cost of \$13,512 for Phase 2; the other half would be fund-raised using the Green Thumb Initiative described below.

If funded, the committee would move forward with the tree planting this fall, and the tree service and lilac hedge next spring. Tree planting is best done in the fall and this would allow us to take advantage of a significant 30% sale by Lanoha's.

The Committee's Phase 2 recommendations are detailed below followed by the status of the original phases presented to the Board last spring. Thank you and please let us know if you have any questions.

#### **Recommendations for Beautification Phase 2**

<ul> <li>Plant 9 linden trees @ \$525 each to replace those that were recently blown over or died previously.</li> <li>This would restore the beauty of the walkway to its original state.</li> <li>Prices are from Lanoha's—2.5-3-inch caliper and includes delivery, planting, two waterings, 2-year warranty.</li> </ul>	\$4,725	\$3,307.50 (30% off Sept Sale)
<ul> <li>Plant 9 new trees (3 red maples @\$525 each; 3 Northern red oaks @\$575; and 3 tulip trees @\$600 each) in two rows outside of lindens to shade roots, protect lindens, and further beautify entrance path.</li> <li>New trees would add diversity, color, and collective wind protection.</li> <li>New trees would be placed in a way that allows access points from path to open fields.</li> <li>Prices are from Lanoha's—2.5-3-inch caliper and includes delivery, planting, two waterings, 2-year warranty.</li> </ul>	\$5,100	\$3,570 (30% off Sept Sale)
3. Plant hedge of 100 lilacs @\$50 each  • A lovely hedge would replace the view of the unattractive hog wire fence with a natural, sound-proofing barrier.  • Combination of hearty Common Purple (10-15 feet), Common White (10-15 feet), and Bloomerang (5 feet) lilacs.  • Prices are from Mulhalls—3-gallon size; they are checking with supplier for stock and for machinery to plow a row for easier planting by AAHA volunteers.	\$5,000	\$3,500 (30% off Sept Sale)
4. Tree Service to thin limbs on existing 7 lindens to protect against future windstorm damage. #### **MOU with City and Army Corps**

Funding the construction of a new fence is currently undecided. Still, it is in the interest of the AAHA to follow up on the verbal offer by the Army Corps to enter into a maintenance agreement in advance of settling the fence funding issue. Specifically, AAHA would enter into a Memorandum of Understanding with the City Parks and Rec and U.S. Army Corps of Engineers to allow replacement of the hog wire fence with a more visually appealing fence in exchange for the AAHA agreement to maintain the fence and weed-whack/mow the area adjoining the fence.

#### **Green Thumb Initiative**

In order to help fund beautification efforts on all common spaces within AAHA, the Committee recommends a donation initiative with the following donor levels and recognition program.

\$50—Big Bluestem \$100—Butterfly Milkweed \$250—Purple Coneflower \$500—Goldenrod \$750—Sunflower \$1,000—Prairie Blazing Star

In addition to paying annual dues, homeowners may choose to make donations toward beautification projects that the Board designates on a case-by-case basis. The AAHA webmaster would advertise the available projects and record the donations by funding levels on the AAHA website, following the preference of the donor (either name, anonymous, in memory of, in honor of). Donations by funding levels could also be added to each newsletter and the AAHA Facebook page. Large donations could be recognized with plaques or other forms of recognition, at the discretion of the board and in negotiation with the donor.

# Status of Original Beautification Phases for Viewing Area

**Phase 1** – Spring 2024, board would fund supplies, volunteers would provide labor

- Clean up the area by removing cement border, tarp, wooden trellis, and bat house—DONE!
- Apply mulch around 12 trees to protect roots—DONE!
- Repair 9 dead patches in field by applying drought-tolerant RTF grass seed and Dutch white clover, which provides nitrogen for grass (approx. 9,100 square feet) —DONE!
- Repair/replace cracked cement pad (6'X4.5') at entrance to remove tripping hazard—by contract TBD by AAHA operations

**Phase 2** – Fall 2024, board would fund supplies, volunteers would provide labor

- Aerate and overseed field to increase RTF/clover (by volunteers or contract)
   NO LONGER NEEDED
- Contract to install split-rail fence, subject to MOU between AAHA and City
- Install steel arbor at entrance with sign "Armbrust Acres HOA"
- Plant two rows of trees on outside of lindens to shade roots, protect lindens, and further beautify entrance path
- Plant daffodil bulbs in mulched areas

Phase 3 – Spring 2025, board would fund supplies, volunteers would provide labor

- Plant row of shrubs along fence to beautify the area and create natural barrier
- Plant pollinator gardens with drought-tolerant perennials and shrubs
- Consider applying for status as "Certified Pollinator Garden" or Wildlife Habitat

# Phase 4 – Ongoing

• Maintain area through use of contract mowing service, long-term volunteers, and one-time volunteer project

Project Request of HOA is maximum of \$9568.56 - \$7900.00 donor = \$1,668.56

If able to do the Assemble and Install by donor volunteers on the benches it would reduce that total to + or - \$1,000
